Eligibility

This Regatta is open to sailboats of ancient vintage and/or classic design. Spinnakers allowed in all Classes. Yacht Club membership is not required to enter. AMSS reserves the right to reject and return entries.

Race Type & Course Description

The race is a pursuit type race. The race consists of a 12.5nm course in San Diego Bay/off Point Loma that will start near SD Channel Buoy #17, proceed seaward to SD Channel Buoy #3, East to near the Navy Mooring Buoy 'TG-1' and then back in the bay finishing near SD Channel Buoy #17. See Sailing Instructions for precise Course.

Classes

For the purposes of scoring, the fleet will be subdivided into the following Five (5) classes:

- *Classic "A"*
- *Classic "B"*
- *Sloops & Cutters*
- *Split Rigs*
- *Pacific Class (Spinnakers allowed)*
