

"This" and "That"

The Coast Guard has been soliciting comments about the new users fees we will have to start paying soon. They seem to be leaning toward a decal valid for the federal fiscal year Oct.1-Sept 30. Still no idea how we are supposed to pay and to whom or where???

The Coast Guard is going to start enforcing licenses for VHF marine radios. They plan to give out written warnings through Oct. 1, 1991 and after that boaters found with unlicensed radios will be subject to a criminal misdemeanor that carries maximum penalties of a \$10,000 fine and a year in jail. They are trying to cut down on the number of fake distress calls and mususe of Channel 16. Licenses are available through the FCC for \$35.00/five years, no test involved.

Have you heard about the proposal by Sen. Leroy Greene, D-Sacramento, to tax at 5% the cost of a new pleasure boat that exceeds \$10,000. Now California is trying to get into the act (and our pocketbooks) some more. How about the proposal to raise the boating registration fee from \$5 to \$12...Looks like time to write to our representatives in Sacramento...again.

Virginia, owned by the Nautical Heritage Society, was chosen in April for the National Register of Historic Places. This places her one of 89 boats among the 56,000 structures registered. Congratulations from AMSS.

Don't forget about the challenge!.... W.H.O.A. vs. AMSS for the "Dana Cup", to be run on October 6, 1991 at Dana Point.

#### Ancient Mariners-Lahaina Yacht Club San Diego to Maui Race June 9, 1991

The fourth Ancient Mariners San Diego to (Lahaina) Maui Race is ready to get underway at noon June 9, 1991. The start will be inside San Diego Bay, south of the fishing pier on Shelter Island. The race committee boat will be the newly refitted *Medea* owned by the San Diego Maritime Museum. Wayne Kenniston and the San Diego Cannoneers will be on hand during the start to send off the Maui Racers in fine style. The Ancient Mariners are heartily encouraged to sail with the Maui racers and escort them to sea. The start will also be visible to the public from Shelter Island. The Ancient Mariners booth on on Shelter Island will form the other end of the start line, and will provide race information and T-shirt sales for those watching the start. The two entries from the San Francisco bay area will be arriving in San Diego by about June 4. The 5 entries will be making final preparations from Koehlers (*Eventide* and *Rowena*) and Southwestern Yacht Club (*Caprice*, *Dauntless* and *Molly Sue*). With the racers in only two places, it gives a great opportunity for the club members to go by and see the boats, give a little unwanted advice and do a little "tire kicking". The Maui Race entrants, crews and a short history of the boats are given below.

Caprice 50 ft. Bill Lapworth double ended sloop. Caprice was launched as Khamsire in 1962 from the Cheoy Lee Yard. Caprice is hull #4 of 6 built to Bill Lapworths design and was considered state of the art in Transpac racers at the time. Caprice and a sistership placed first and second in class in the 1962 transpac. Since that time Caprice has cruised Mexico several times. David and Barbara Lenschmidt have been refitting Caprice since December 1989, although she has required no structural work. David and Barbara are interested in cruising the Hawaiian Islands and observing the total eclipse on July 11, 1991 on the big island. The Lenschmidts have entered Caprice in the Santa Cruz to Santa Barbara race as a shake-down sail on the way to San Diego, we wish them good luck! What a great warm up race, they will likely see more weather there than during the Maui Race. Personal note: David had a heart transplant 3 years ago and is doing great! The crew of Caprice includes: Ray Duodell, Kew Katz, Linda Keigler, David Lee, Ralph Lucas, and the owners David and Barbara Lenschmidt.

Dauntless 61 ft. John G. Alden staysail Schooner. Dauntless was designed for Horace Merwin Sr. of the New York Yacht Club, a close friend of J.G. Alden, and she was built in 1930 by the Dauntless shipyard (still in operation) in Essex Conn. The schooner was rebuilt in 1975 by Direcktors yard in Florida and was then sailed extensively in the San Francisco bay area. She was purchased by Paul and Peggy Plotts in 1984 and moved to San Diego. The Plotts family and Dauntless have been largely responsible for the schooner revival in San Diego through their Billy Bones schooner races. Dauntless sailed in the 1985 AMSS San Diego to Maui race and placed first in the schooner class. The crew for the 1991 race is well seasoned and includes: Keith Korporaal, Steve Kurzensky, Jack Lower, Jerry Newton, Bill Reich, and the owner Paul Plotts.


Eventide 36 ft. Bill Lapworth L-36 (#31) Sloop was launched as Eventide II in 1958 and was built by Kalagian and Chapman in Costa Mesa, Ca. Eventide II was sailed as a

"factory boat" by Steve Newmark a well known So. Cal. yacht Broker who was marketing the L-36 at the time. *Eventide II* was shipped to Buenos Aries for the fith Buenos Aries to Rio De Janero Race (1200 mi). With six crew including: Steve Newmark, his wife and cousin, Bill Lapworth, and Raleigh Kalagian the L-36 sailed to a second in class C and Seventh overall out of 25 boats. These results were published in the March 1959

Yachting magazine, the race was probably in Jan. 1959. Bob Griffiths purchased and renamed her *Eventide* in 1976 and has maintained her in bristol condition since then. Bob will be sailing *Eventide* down from the San Francisco Bay area after the Master Mariners Race on Memorial Day. Sailing with Bob Griffiths will be Louis Chales Nickles and Mark Ratterree.

Molly Sue 50 ft. Kettenburg 50 sloop. Molly Sue is hull #22 of 23 of the Kettenburg K-50 sloops, and was launched as Tango Time in 1964. The Kettenburg 50 was one of Kettenburg Marine's (of San Diego) last wooden boats and is a popular cruising yacht. Molly Sue was completely gutted in 1987 and has had a complete refit by the owners since that time. She is single planked phillipine mahogany over white oak and has not needed any structural restoration. The owners, Ron and Molly Bodeen are looking forward to an open ended cruise in the Hawaiian Islands and beyond after the Maui Race. The crew of Molly Sue includes: John Beard, Ron and Molly Bodeen, Elizabeth DeVries, Jim Fellows, Rod Latimer, Robert Smally, and Gerry West. There is reportedly a lot of transpac experience in this crew and Molly Sue was seen sailing to first place in the 1991 Yesteryear Regatta.

Rowena 49 ft Phil Rhodes sloop designed in 1961. Rowena is a keel sloop, designed after the legendary centerboard sloop Thunderhead that dominated east coast racing during the late 1950's and 1960's. Rowena was built for Don Dalziel by Lester Stone in the Bay area in 1962. Rowena raced under the CCA rule in the Bay area for several years and cruised to the So. Pacific in 1964. She raced in the 1967 and 1969 transpacs. She was owned by Barry Stephens of Stephens Marine from 1980 to 1987 when she cruised Mexico, the So. Pacific, Hawaii and Alaska. She reportedly logged over 100,000 miles during this period alone. Tom and Wyndham Jackson have been restoring Rowena to true yacht condition since 1987. In 1990 Tom and Wyndham did find time to cruise the Sea of Cortez with their daughter Sarah who was less than a year old at the time. The crew of Rowena includes: Charlie Gallman, Kimberly Hemphill, C.F. Koehler, Galin Thompson, Sandy Vasser, and owner Tom Jackson. Rowena also showed a great turn of speed in this years heavy air Yesteryear Regatta, winning her class.

#### WELCOME ABOARD

#### THE RULES

- 1 The skipper always makes the rules.
- The rules are subject to change at any time without prior notification.
- 3 No crew can possibly know all the rules.
- 4 If the skipper suspects the crew knows all the rules, then the skipper must immediately change some or all of the rules.
- 5 The skipper is never wrong.
- If the skipper is wrong, it is due to a misunderstanding of something the crew said or did wrong, or general ineptness or stupidity on the part of the crew.
- 7 If #6 applies, the crew must apologize quickly for causing the misunderstanding.
- 8 The skipper may change his/her mind at any point.
- 9 The crew may never change their minds without express written consent from the skipper.
- The skipper has the right to be angry or upset at any time.
- The crew must remain calm at all times unless the skipper wants them angry or upset.
- 12 The skipper is under no obligation to let the crew know whether or not he/she wants the crew to be angry or upset.
- Only the skipper may decide when every thing is okay again.
- Only the skipper may begin a conversation at any given point in his/her mind and the crew is expected to know the logic and reason for the conversation.
- 15 Common sense is defined as what the skipper believes is true.
- The crew is expected to know in all circumstances what the skipper meant to say, even when it is not the same as what the skipper actually said.
- 17 The crew may never quote the skipper.
- Sail trim, right of way and compass head ings do not apply except as defined by the skipper.


